

Dear Director Paulsen:

On behalf of the Distilled Spirits Council of the United States (DISCUS), a national trade association representing producers and marketers of distilled spirits sold in the United States, I write to you to comment regarding the recommendation made by the Iowa Board and Commission Review Committee (BCRC) with regard to the Iowa Alcoholic Beverages Division (ABD).

DISCUS believes that it is always appropriate for state governments to reflect and review their constitutional and statutory charge and mission, organization, processes, procedures, and effectiveness to properly ensure that its citizens and regulated industries are being properly served. In that vein, we applaud the administration for the creation of the BCRC to examine the 256 state boards and commissions to determine whether changes are needed.

The ABD, of course, was part of this review. The BCRC made a recommendation of "Reorganize / Other Changes". While there could be reasons for changes to ABD, we simply do not know enough yet about what is envisioned for ABD to provide substantive comment at this point. We would note that there has already been a significant reorganization at ABD which was made earlier this year. Under legislation passed and signed into law, the ABD is now a part of the Department of Revenue.

We would note for the record that, generally speaking, ABD gets high marks from stakeholders that it licenses and regulates among all state alcohol regulatory and enforcement agencies. While there is always room for improvement, ABD has a demonstrated record of openness in its communications and workings with industry stakeholders, citizens, law enforcement, and public health organizations, and willingness to engage these groups in dialogue, and incorporate suggestions.

We look forward to following the BCRC's deliberations leading to the final report due later this month. We are available and willing to provide additional input and answer any questions that the Committee may have.

My name is **and I** chair the Iowa Council on Homelessness. Thank you all for the work you have undertaken to identify efficiencies among Iowa's many boards and commissions. You certainly had a daunting task! However, I write today to urge you to remove the Council from your list of recommended reductions to the current list of boards and commissions.

The Council has forever been somewhat unique in the mix of citizens and state offices represented among its membership. Last year, the Council underwent significant revision after a 2-year process of reducing membership from 39 to 20. This was necessary in order to make the Council manageable and focus on applying resources in an effective manner to Iowa's growing homelessness and affordable housing needs. The Iowa Council on Homelessness now consists of citizens engaged in homeless services, those with lived experience and those agencies and offices (Departments of Education, HHS, Attorney General's Office) with resources that can be applied to homelessness, This coordination is crucial, as there is no other body, let alone commission or board, positioned to coordinate resources. So it is important for the Council to continue to exist and function in order to address lowa's homelessness and affordable housing.

In the winter, the lines sag to within a few inches of the roof. In the winder we have rain that freezes and forms icicles on these cables which are black and as soon as the sun warms the cables, the icicles drop onto my roof. This ruined the last roof with holes penetrating the shingles.

Century Link (formerly Qwest) offered to move the cables for \$5,000 (in 2010).

My position with IUB is that these cables do not meet IEEE standards, is not safe, and creates damage for me.

IUB reached out to the utility. I was not able to 'see' their response, but the reply I received from IUB was that they couldn't help.

Shocking to me - a utility does not meet electric standards and yet IUB would not help protect a nearly lifelong lowan.

Please strip the power of IUB where they intend to strip prime, fertile farmland from those people trying to make a living, support a family, and feed the world.


This is most urgent in nature and I am hopeful, this Committee will make the proper recommendation on the IUB.



As the director of a non profit organization that seeks to end homelessness in Iowa I partner and regularly meet with several dozen other agencies to make impacts in our part of the state. This group of advocates for housing and homeless services has a member that is on the Iowa Council on Homelessness. We believe that this gives our group a voice and a connection at the state level. Please consider not only keeping this group, but strengthening it. By working together, we are able to create positive, cost saving impacts for families and the state.

A few points to consider:

- State funding to address homelessness is very limited. Shelter Assistance Fund grants each year typically total between \$1 and \$2 million. Without a body to advocate for funding, there is no voice for lowans experiencing homelessness.

- State staffing to address homelessness is limited and spread across multiple agencies. The Council is specifically constituted to include representatives of state agencies engaged in addressing homelessness. Without the ICH, there would be no forum for coordinating communication and resources; leaving lowa open to missing opportunities for much-needed federal resources.

- Governance and funding streams for HUD programs in Iowa are currently divided among four different units (Continuums of Care). The Council provides a venue for statewide planning and coordination leading to more efficient use of limited resources.

- The ICH has undergone extensive revision of structure and code in the past 3 years. These changes were designed to streamline the process for action, including expansion and coordination of resources. Eliminating the Council before it has a real chance to demonstrate added value under the new structure does not make sense.

- The bimonthly Council meetings are attended not only by the 20 appointed members; typical attendance is 35 – 50. These others include mostly homeless service providers who attend these meetings as the only regular convening of stakeholders.

My name is Courtney Guntly and I work as the Iowa Balance of State Continuum of Care Director, covering 96 counties (excluding Polk, Pottawattamie, and Woodbury). We serve as the planning organization for our geographic area and complete applications for federal housing assistance on behalf of our Continuum of Care (CoC). While we cover a majority of the state, we are by no means a statewide organization and rely on the Iowa Council of Homelessness to bring together the four CoCs operating within Iowa along with the state departments that help to serve homeless Iowans.

Homelessness is increasing in Iowa, and it is integral to have the opportunity to develop a plan with state departments, the CoCs, housing providers, and advocates. The Iowa Council on Homelessness is necessary to facilitate these conversations. In addition, the Council recently underwent a strategic plan and restructure, but has not had the opportunity to truly take action on the plan laid out by the consultant. The Council must have an opportunity to do the work.

A majority of states have an interagency council on homelessness that is supported by the state government. Of our neighbors, only South Dakota does not currently have an interagency council on homelessness; Nebraska, Missouri, Minnesota, Illinois, and Wisconsin all have operating interagency homeless councils.

As homelessness increases across all counties in Iowa, it is more important than ever that the state supports the homeless services system. Very little state funding is provided to homeless services through the Shelter Assistance Fund (a percentage of the real estate transfer tax) and without additional funding, having a regular opportunity for collaboration through the Iowa Council on Homelessness is vital.

I urge you to remove the Iowa Council on Homelessness from the list of state boards that will be eliminated.

As an Iowa resident and an employee that works within the homeless sector, I am submitting my comment today regarding the status of the Iowa Council on Homelessness (ICH) and urge the Board and Commissions Review Committee to consider continuing to support ICH. I have worked in the homeless sector for over 15 years in various levels from providing case management to advocacy across the state and have served as a former member of ICH.

On any given night there are over 2,700 people that are homeless in Iowa. Homelessness continues to be a concern across the state and having a statewide council is vital. To reference the finding noted that funding of current advisory boards are ineffective or inefficient: The ICH has undergone extensive revision of structure and code in the past 3 years. These changes were designed to streamline the process for action, including expansion and coordination of resources. Eliminating the Council before it has a real chance to demonstrate added value under the new structure does not make sense. ICH provides a venue for statewide planning and coordination leading to more efficient use of limited resources. To reference the finding regarding the participation: ICH meetings are attended not only by the 20 appointed members; typical attendance is 35 - 50. These others include mostly homeless service providers who attend these meetings as the only regular convening of community partners.

For the State to lead by example, we need to show initiative of how the state of Iowa is supporting people experiencing homelessness. This is an area where improvement is needed. Currently, state funding to address homelessness is extremely limited. Shelter Assistance Fund grants each year typically total between \$1 and \$2 million. Without a body to advocate for funding, there is no voice for Iowans experiencing homelessness. State staffing to address homelessness is limited and spread across multiple agencies. The Council is specifically constituted to include representatives of state agencies engaged in addressing homelessness. Without ICH, there would be no forum for coordinating communication and resources; leaving Iowa open to missing opportunities for much-needed federal resources and engaging other systems of care to work collaboratively on preventing and ending homelessness.
