Addendum 2 - Broadband Grant NOFA #003 ("NOFA") Scoring Rubric

Pursuant to Section 3 (Scoring Methodology) of the NOFA, an addendum identifying the specific point values assigned to each evaluation factor or subfactor to be scored as it relates to Infrastructure Projects and Adoption Projects submitted in response to the NOFA will be posted immediately prior to the Application due date. This Addendum satisfies that requirement. Regardless of whether an Applicant's Project is comprised of only one or both components, the Broadband Infrastructure and Broadband Adoption components of any proposed Project will be scored and evaluated separately.

Notwithstanding anything in the NOFA to the contrary, in both the Evaluation Committee making its recommendation(s) to the Office and the Office making its final Award decision(s), neither the Evaluation Committee nor the Office is bound by any scores or scoring system used to assist in assessing the relative merits of each Application. The scores and scoring system are a tool to facilitate intelligent decision making and a consensus-based decisional process that considers the key factors set forth in the NOFA.

3A Broadband Infrastructure Project Scoring Rubric
