Introduction

On July 1, 2022, the Iowa Department of Human Services and the Iowa Department of Public Health merged to create the Iowa Department of Health and Human Services (HHS). Over the next 12 months, the legacy departments began to merge functions. On July 1, 2023, the Iowa Department on Aging and the Iowa Department of Human Rights also joined HHS. For the purposes of this report, performance and budget data for each legacy department have been reported separately. However, an HHS budget is included.

Overview of Legacy Departments

IOWA DEPARTMENT ON AGING

OVERVIEW

The lowa Department on Aging maintained statutory and contractual relationships with a network of six Area Agencies on Aging, which provide services to older lowans across the state. The Area Agencies on Aging and their contracted service providers delivered nutrition, access, home and community-based services, and caregiver services designed to support individuals in their homes and communities.

MISSION

The Iowa Department on Aging will provide resources, tools, and support to enable Area Agencies on Aging and partners with common goals to effectively deliver core services — Information & Service Assistance, Nutrition & Health Promotions, and Services to Promote Independence — to our consumers.

VISION

The lowa Department on Aging supports accessible, integrated services to older adults, adults with disabilities, and caregivers to assist them in maintaining their independence, dignity, autonomy, health, safety, and economic well-being.

IOWA DEPARTMENT OF HUMAN RIGHTS

OVERVIEW

The lowa Department of Human Rights linked state and federal programs with community-based organizations across the state to effectively serve elderly, disabled and low-income lowans; served diverse populations and communities via seven offices (Native Americans, African Americans, Asian and Pacific Islanders, Latinos, Women, Persons with Disabilities, and Deaf Services); and conducted research, planning, data coordination, and information clearinghouse functions for the state's justice system.

We help individuals attain economic independence by ensuring access to government services and advancing educational achievement and entrepreneurial success consistent with their aspirations.

supports to assist needy families to meet basic needs for good health, safety, and consistency and continuity in their homes, work, and communities.
