The Agency may increase an Award where a higher-ranking Applicant declines an award that had impacted a lower-ranking Applicant.

DOM will submit the NOIA to NTIA for approval as part of the State of Iowa's Final Proposal required as a part of the BEAD program. Any changes to grantees or grant award amounts required by NTIA will be reflected in an amended NOIA that will be published online at <http://dom.iowa.gov/broadband>.

Adversely affected Applicants have five (5) days to submit a notice of intent to appeal this Award decision in accordance with Iowa Administrative Code chapter 129-11.3(1). Applicants may appeal an adverse decision only for a timely submitted Application. Appeals may clearly and fully identify all issues being contested and demonstrate what requirements or procedures in Applicable Law, rule, or the NOFA were violated. In the event of an appeal, the Agency will continue working with other successful Applicants pending the outcome of the appeal.
