Agency Overview

The Iowa Department of Public Safety is an agency within the executive branch of Iowa State Government. It was established in 1939, when Iowa Code Chapter 80 was adopted.

The Department has seven divisions:

- Administrative Services,
- Criminal Investigation,
- State Fire Marshal,
- Intelligence and Fusion Center,
- Professional Development and Support Services,
- Narcotics Enforcement,
- Iowa State Patrol,

and the Office of the Commissioner, which includes the Commissioner, the Executive Officer to the Commissioner, the Department's Policy Advisor, General Counsel, the Commissioner's Executive Secretary, and six bureaus:

- Office of Drug Control Policy,
- Governor's Traffic Safety Bureau,
- Interoperable Communications Bureau,
- Governor's School Safety Bureau,
- Professional Standards Bureau, and
- Strategic Communications Bureau.

The Department's mission is "to serve the people of Iowa by providing public safety services with leadership, integrity, and professionalism." To support a vision of ensuring Iowa remains a safe and prosperous place to live and visit, the Department provides several services and programs. This report outlines the Department's progress toward achieving its goals in fiscal year 2025 (FY2025). Out of the 68 measures the Department tracks, 48 were met.



Strategic Initiative 1: Provide public safety services on Iowa's roadways.

To support this initiative, the Department aims to reduce preventable injuries and deaths on Iowa roads through education and enforcement.

Highlight: Every calendar year, the Iowa State Patrol establishes traffic safety goals. Goals for FY2025 focused on Seatbelts, Impaired driving, Distracted driving, and Excessive speeding (S.I.D.E.). By getting the public to "S.I.D.E. With Us," the State Patrol seeks to reduce preventable traffic fatalities below 300 annually. The Iowa State Patrol works with the Iowa Governor's Traffic Safety Bureau and local agencies in achieving its goals. Iowa fatalities decreased from 347 in FY2024 to 341 in FY2025. The Iowa State Patrol continues to partner with local and county agencies and its Midwest state police counterparts to drive crashes and fatalities down.

* While it remains a goal of the Department to reduce preventable injuries and deaths on Iowa's roadways, this responsibility falls across all law enforcement and relies on public compliance with Iowa's laws and traffic safety best practices. Some variables are outside the Department's control.

Strategic Initiative 2: Provide critical aid and support to criminal justice partners through forensic science services.

Highlight: The DCI Criminalistics Laboratory provides professional forensic scientific services and support to the criminal justice community throughout Iowa. In FY2025, the DCI Lab achieved an average turnaround time for case assignments of 58 days, a 5% decrease from FY2024.

Strategic Initiative 3: Provide crucial and timely criminal history information to employers on prospective hires in the education, healthcare, and childcare industries.

Highlight: During FY2025, the Criminal History Dissemination Unit initiated enhancements to the Single Contact Repository (SING), which is a web-based service managed by the Department and provides a central location for authorized agencies to connect to DPS' Iowa criminal history and sex offender registry databases, HHS' child abuse and dependent adult abuse registries, and DIAL's professional licensing databases. With this upgrade, a complete overhaul will occur to the SING user interface, modernizing a 25-year-old process to be more efficient, accessible, and user-friendly. This upgrade will leverage the enhancements that were made to the Dissemination Unit's work processes within Computerized Criminal History (CCH) during FY2024, to ensure that the Department continues to provide accurate and timely criminal history records and excellent customer service to agencies that serve Iowa's most vulnerable populations such as healthcare facilities, childcare centers, and schools, as well as state agencies that license those in the medical and education fields. Completion of this project is expected to be in January 2026.
