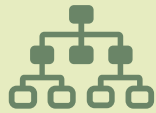

Program Action Plan:

Disability Services was developed in response to HF 2673 which moved the administration of disability services provided by MHDS Regions to HHS division of Aging and Disability Services. Implementation starts July 1, 2025. Program goals and action plans will be developed after baseline information is obtained through the first year of implementation.

The Autism Support Program will continue to engage in network building with providers and increase public information shared to ensure families of eligible individuals have access to applied behavior analysis (ABA) services for those with an autism diagnosis. 2026 Target has been significantly decreased due to decreased funds for the Autism Support Program (ASP). Historic program fund balance was appropriated by the legislature to Chidserve leaving \$163,000 for SFY26. ASP is currently serving 8 children and available funds will not allow for growth.
