ORGANIZATIONAL STRUCTURE

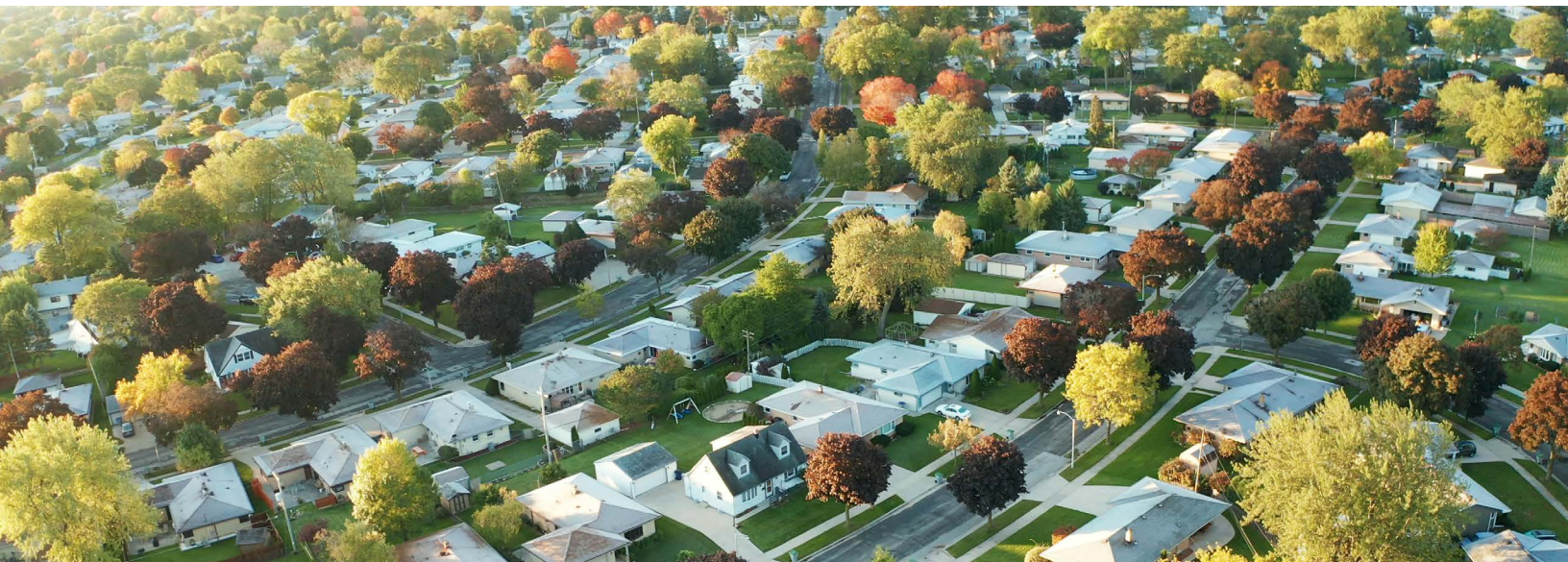
The organizational structure of the Iowa Economic Development Authority is outlined in the IEDA IFA Org Chart 4.8.25 See Appendix A.

IFA BOARD OF DIRECTORS

The Iowa Finance Authority (IFA) board represents a diverse group of professionals who are dedicated to enhancing the quality of life for Iowans. Board members are appointed by the Governor, confirmed by the Iowa Senate, and serve staggered six-year terms. The Board reviews progress in implementation of IFA's programs, consideration and approval of proposals and certain program awards, establish policy as needed and other actions as necessary and appropriate.
