- 29 DEPARTMENT OF HEALTH AND HUMAN SERVICES HUMAN SERVICES.
- 30 This division makes appropriations from the general fund of the
- 31 state and the federal temporary assistance for needy families
- 32 block grant to the department of health and human services
- 33 for programs and services relating to human services. The
- 34 reimbursement section addresses reimbursement for providers
- 35 reimbursed by the department of health and human services.

- 1 DEPARTMENT OF HEALTH AND HUMAN SERVICES HUMAN RIGHTS.
- 2 This division makes appropriations from the general fund of
- 3 the state to the department of health and human services for
- 4 programs and services related to human rights and from the
- 5 juvenile detention home fund to the department of health and
- 6 human services for juvenile detention homes.
- 7 HEALTH CARE ACCOUNTS AND FUNDS. This division makes certain
- 8 health-related appropriations. A number of the appropriations
- 9 are made for purposes of the Medicaid program in addition to
- 10 the general fund appropriations made for this purpose for the
- ll same fiscal year.
- 12 DECATEGORIZATION AND CARRYOVER FUNDING. This division
- 13 provides for the transfer of carryover decategorization funds
- 14 that remained unencumbered or unobligated at the close of FY
- 15 2020-2021, to the Medicaid program for FY 2024-2025.
- 16 PRIOR APPROPRIATIONS AND OTHER PROVISIONS. This division
- 17 provides for nonreversion of funds appropriated for the family
- 18 investment program general fund, state child care assistance,
- 19 child and family services, field operations, the more options
- 20 for maternal support program, and general administration for
- 21 FY 2022-2023 to the close of the succeeding fiscal year. The
- 22 division also increases the appropriation for FY 2022-2023 from
- 23 the quality assurance trust fund to the department of health
- 24 and human services to supplement the medical assistance program
- 25 appropriation. The division takes effect upon enactment.
- 26 ELIMINATION OF REPEAL OF HOSPITAL HEALTH CARE ACCESS
- 27 ASSESSMENT PROGRAM. This division eliminates the repeal of
- 28 Code chapter 249M, the hospital health care access assessment
- 29 program. The division takes effect upon enactment.
- 30 REALIGNMENT PROVISIONS. This division amends provisions of
- 31 2023 Iowa Acts, Senate File 514, relating to the director of
- 32 health and human services buying and selling real estate and
- 33 relating to the department of health and human services rather
- 34 than the department of education distributing school ready
- 35 children grants account moneys.

- 1 PUBLIC HEALTH EMERGENCY PROVISIONS COVID-19 REGULATIONS.
- 2 This division provides that for FY 2023-2024, notwithstanding
- 3 state administrative rules to the contrary, to the extent
- 4 federal regulations relating to the COVID-19 pandemic differ
- 5 from state administrative rules, including applicable federal
- 6 waivers, the federal regulations are controlling during the
- 7 pendency of the federally declared state of emergency and for
- 8 such period of time following the end of the federally declared
- 9 state of emergency applicable to the respective federal
- 10 regulations.
