DIVISION I

FY 2020-2021 APPROPRIATIONS

DEPARTMENT FOR THE BLIND

Section 1. ADMINISTRATION. There is appropriated from the general fund of the state to the department for the blind for the fiscal year beginning July 1, 2020, and ending June 30, 2021, the following amounts, or so much thereof as is necessary, to be used for the purposes designated:

29 Sec. 3. Section 261.25, subsections 1 and 2, Code 2020, are
30 amended to read as follows:

31 1. There is appropriated from the general fund of the state
32 to the commission for each fiscal year the sum of ~~forty-seven~~
33 forty-eight million ~~seven~~ eight hundred ~~three thousand four~~
34 ~~hundred sixty-three~~ ninety-six thousand fifty dollars for
35 tuition grants to qualified students who are enrolled in

1 accredited private institutions.

2 2. There is appropriated from the general fund of the
3 state to the commission for each fiscal year the sum of four
4 hundred ~~twenty-six~~ thirty-six thousand ~~two~~ eight hundred
5 ~~twenty~~ seventy-six dollars for tuition grants for qualified
6 students who are enrolled in eligible institutions. Of the
7 moneys appropriated under this subsection, not more than eighty
8 thousand dollars annually shall be used for tuition grants to
9 qualified students who are attending an eligible institution
10 under section 261.9, subsection 3, paragraph "b".

11 Sec. 4. CHIROPRACTIC LOAN FUNDS. Notwithstanding section
12 261.72, the moneys deposited in the chiropractic loan revolving
13 fund created pursuant to section 261.72, for the fiscal year
14 beginning July 1, 2020, and ending June 30, 2021, may be used
15 for purposes of the chiropractic loan forgiveness program
16 established in section 261.73.

17 Sec. 5. WORK-STUDY APPROPRIATION. Notwithstanding section
18 261.85, for the fiscal year beginning July 1, 2020, and ending
19 June 30, 2021, the amount appropriated from the general fund
20 of the state to the college student aid commission for the
21 work-study program under section 261.85 shall be zero.

22 Sec. 6. 2019 Iowa Acts, chapter 154, section 17, subsection
23 1, paragraph d, is amended to read as follows:

29 a. From the moneys deposited in the school ready children

6 early childhood Iowa fund, \$2,318,018 shall be used for efforts

8 programs. Moneys allocated pursuant to this paragraph may be
9 used for additional staff and for the reimbursement of staff.
10 The early childhood Iowa state board may reserve a portion
11 of the allocation, not to exceed \$88,650 for the technical
12 assistance expenses of the early childhood Iowa state office,
13 including the reimbursement of staff, and shall distribute
14 the remainder to early childhood Iowa areas for local quality
15 improvement efforts through a methodology identified by the
16 early childhood Iowa state board to make the most productive
17 use of the funding, which may include use of the distribution
18 formula, grants, or other means.

19 c. Of the amount appropriated in this subsection for
20 deposit in the school ready children grants account of
21 the early childhood Iowa fund, \$825,030 shall be used for
22 support of professional development and training activities
23 for persons working in early care, health, and education by
24 the early childhood Iowa state board in collaboration with
25 the professional development component groups maintained by
26 the early childhood Iowa stakeholders alliance pursuant to
27 section 256I.12, subsection 7, paragraph "b", and the early
28 childhood Iowa area boards. Expenditures shall be limited to
29 professional development and training activities agreed upon by
30 the parties participating in the collaboration.

9 report card for each attendance center, for internet site and
10 data system support:

22 For purposes of purchasing a statewide license for an early
23 warning assessment and administering the early warning system
24 for literacy established in accordance with section 279.68 and

27 The department shall administer and distribute to school
28 districts and accredited nonpublic schools the early warning
29 assessment system that allows teachers to screen and monitor
30 student literacy skills from prekindergarten through grade

33 costs to purchase a statewide license for the early warning

24 paragraph, the moneys appropriated in this lettered paragraph
25 shall be expended for salaries, staffing, institutional
26 support, activities directly related to recruitment of

33 Sec. 10. ENERGY COST-SAVINGS PROJECTS — FINANCING. For
34 the fiscal year beginning July 1, 2020, and ending June 30,
35 2021, the state board of regents may use notes, bonds, or

1 other evidences of indebtedness issued under section 262.48 to
2 finance projects that will result in energy cost savings in an
3 amount that will cause the state board to recover the cost of
4 the projects within an average of six years.

5 Sec. 11. PRESCRIPTION DRUG COSTS. Notwithstanding any
6 provision of chapter 270 to the contrary, the department of
7 administrative services shall pay the state school for the
8 deaf and the Iowa braille and sight saving school the moneys
9 collected from the counties during the fiscal year beginning

7 for implementation of adult education and literacy programs
8 pursuant to section 260C.50.

9 (3) From the moneys appropriated in this lettered paragraph

25 From the moneys appropriated in this lettered paragraph
26 "f", not more than \$50,000 shall be used by the department for

28 including work-based learning, for intermediary networks.

29 g. For support costs associated with administering a
30 workforce preparation outcome reporting system for the purpose
31 of collecting and reporting data relating to the educational
32 and employment outcomes of workforce preparation programs
33 receiving moneys pursuant to this subsection:

35 2. COLLEGE STUDENT AID COMMISSION

1 For purposes of providing skilled workforce shortage tuition
2 grants in accordance with section 261.130:

4 3. Notwithstanding section 8.33, moneys appropriated
5 in this section of this Act that remain unencumbered or
6 unobligated at the close of the fiscal year shall not revert
7 but shall remain available for expenditure for the purposes

9 EXPLANATION

10 The inclusion of this explanation does not constitute agreement with
11 the explanation's substance by the members of the general assembly.

12 This bill appropriates moneys for fiscal year 2020-2021 from
13 the general fund of the state and other funds to the college
14 student aid commission, the department for the blind, the
15 department of education, and the state board of regents and its
16 institutions. The bill is organized by divisions.

17 DIVISION I — FY 2020-2021. The bill appropriates to the
18 department for the blind for its administration.

19 The bill includes appropriations to the college student aid
20 commission for general administrative purposes, administration
21 of the future ready Iowa skilled workforce last-dollar
22 scholarship program, the health care professional recruitment
23 program, the national guard educational assistance program,
24 the all Iowa opportunity scholarship program, the teach Iowa
25 scholar program, the rural Iowa primary care loan repayment
26 program, the health care loan repayment program, and the future
27 ready Iowa skilled workforce last-dollar scholarship program.
28 The bill increases the standing limited appropriation for Iowa
29 tuition grants to qualified students enrolled in accredited
30 private institutions and to qualified students attending an
31 eligible institution.

32 The bill amends 2019 Iowa Acts, chapter 154, section 17, to
33 provide for the transfer of \$600,000 from the future ready Iowa
34 skilled workforce grant fund to the future ready Iowa skilled
35 workforce last-dollar scholarship fund. This provision takes

1 effect upon enactment.

2 The bill appropriates moneys to the department of education
3 for purposes of the department's general administration,
4 career and technical education (CTE) administration, division
5 of vocational rehabilitation services including independent
6 living programs, the entrepreneurs with disabilities program,
7 and independent living centers, state library for general
8 administration and the enrich Iowa program, public broadcasting
9 division, career and technical education reimbursement for
10 expenditures made by CTE regional planning partnerships, school
11 food service, early childhood Iowa fund, expansion of the
12 federal Individuals with Disabilities Education Improvement Act
13 birth through age three services, early head start projects,
14 textbooks for nonpublic school pupils, the student achievement
15 and teacher quality program, statewide student assessment,
16 statewide clearinghouse to expand work-based learning,
17 postsecondary summer classes for high school students program,
18 jobs for America's graduates specialists, attendance center
19 performance/general internet site and data system support,
20 the online state job posting system, successful progression
21 for early readers, an early warning system for literacy, the
22 Iowa reading research center, computer science professional
23 development incentive fund, the statewide education data
24 warehouse, the Iowa communications network, children's mental
25 health school-based training and support, for school districts
26 for students with intellectual and developmental disabilities,
27 adult education and literacy programs, distribution to the
28 midwestern higher education compact to pay Iowa's member state
29 annual obligation, and community colleges.

30 For the 2020-2021 fiscal year, the bill reduces the standing
31 appropriations for at-risk children under Code section 279.51
32 and for payment of claims for nonpublic school transportation
33 under Code section 285.2.

34 Statute is enacted to reduce state aid for area education
35 agencies by \$15 million for FY 2020-2021. Statute is

1 amended to provide for the FY 2020-2021 allocation of moneys
2 appropriated for purposes of the student achievement and
3 teacher quality program, and to delay until FY 2021-2022
4 the allocation of moneys for implementing the supplemental
5 assistance for high-need schools provisions of Code section
6 284.11.

7 The bill appropriates moneys to the state board of regents
8 for the board office, universities' general operating budgets;
9 the western Iowa regents resource center; Iowa public radio;
10 the state university of Iowa; Iowa state university of science
11 and technology; the university of northern Iowa; and for the
12 Iowa school for the deaf and the Iowa braille and sight saving
13 school.

14 DIVISION II — WORKFORCE TRAINING PROGRAMS — APPROPRIATIONS
