FY 2021-2022 APPROPRIATIONS

22 of the allocation, not to exceed \$88,650 for the technical  
23 assistance expenses of the early childhood Iowa state office,  
24 including the reimbursement of staff, and shall distribute  
25 the remainder to early childhood Iowa areas for local quality  
26 improvement efforts through a methodology identified by the  
27 early childhood Iowa state board to make the most productive  
28 use of the funding, which may include use of the distribution  
29 formula, grants, or other means.

30        c. Of the amount appropriated in this subsection for

32 the early childhood Iowa fund, \$825,030 shall be used for  
33 support of professional development and training activities  
34 for persons working in early care, health, and education by  
35 the early childhood Iowa state board in collaboration with

2 the early childhood Iowa stakeholders alliance pursuant to  
3 section 256I.12, subsection 7, paragraph "b", and the early  
4 childhood Iowa area boards. Expenditures shall be limited to  
5 professional development and training activities agreed upon by  
6 the parties participating in the collaboration.

17 of northern Iowa; and for the Iowa school for the deaf and the  
18 Iowa braille and sight saving school.

19 The bill amends statute to decrease the state aid for area  
20 education agencies for each fiscal year of the fiscal period  
21 beginning July 1, 2021, and ending June 30, 2023, by \$15  
22 million; to increase the standing appropriations to the CSAC  
23 for purposes of the Iowa tuition grant for qualified students  
24 who are enrolled in accredited private institutions (nonprofit)  
25 and eligible institutions (for-profit); and to provide for the  
26 allocation of moneys appropriated for purposes of the student  
27 achievement and teacher quality program. The provisions  
28 increasing the appropriations for the Iowa tuition grant for  
29 fiscal year 2022–2023 take effect July 1, 2022.

30 DIVISIONS II AND IV — WORKFORCE TRAINING PROGRAMS —  
31 APPROPRIATIONS FY 2021–2022 AND FY 2022–2023. The bill  
32 appropriates moneys from the Iowa skilled worker and job  
33 creation fund to the department of education and the college  
34 student aid commission.
